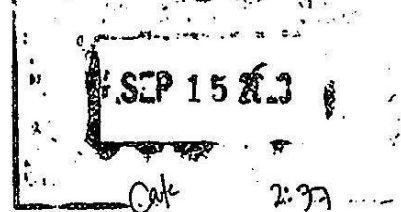

**NOTICE OF RESOLUTION**



In Re: **ERC Case No. 2022-014 RC**

*In the Matter of the Petition for the Approval of the Availment from the Universal Charge for Missionary Electrification (UC-ME) for CY2023, with prayer for the Issuance of a Provisional Authority,*

*National Power Corporation (NPC), Petitioner.*

Notice is hereby given that the Commission, after due deliberation and evaluation, in a Regular Commission Meeting held on 05 September 2023, **RESOLVED** the following matters:

1. National Power Corporation (NPC) is **GRANTED INTERIM RELIEF** authorizing it to collect the Universal Charge – Missionary Electrification (UC-ME) at the UC-ME rate of **PhPo.1822/kWh**, broken down as follows:

Particulars	Rate, PhP/kWh
UC-ME Basic Subsidy Rate	0.1805
RED-CI Rate	0.0017
<b>Total</b>	<b>0.1822</b>

2. All Distribution Utilities (DUs) and the National Grid Corporation of the Philippines (NGCP) are **DIRECTED** to collect the approved UC-ME Rate of **PhPo.1822/kWh** for Calendar Year (CY) 2023 from their consumers and remit the same to the Power Sector Assets and Liabilities Management Corporation (PSALM), on or before the 15<sup>th</sup> day of the succeeding month, until directed otherwise by the Commission; and
3. PSALM is **DIRECTED** to disburse to NPC any amount collected from the implementation of the approved UC-ME Basic Subsidy rate of **PhPo.1805/kWh**.
4. NPC is **DIRECTED** to submit to the Commission a copy of the annual audit reports of the Commission on Audit (COA) relative to the utilization of the UC-ME; and

5. The final UC-ME Basic Subsidy rate will be determined by the Commission in its formal *Order* on the above-subject case.

This *Notice* is being issued due to lack of material time in promulgating the official *Order* in the above-subject case. The formal *Order* will be issued shortly.
